I understand that the School District and the foregoing individuals are to incur no liability as a result of any injury arising from the self-administration of medication or use of an epinephrine auto-injector, regardless of whether authorization was given by my student's parents or guardians or by my student's physician, physician's assistant, or advanced practice registered nurse, provided, however, this indemnity and hold harmless commitment does not apply to the willful and wanton conduct of the foregoing indemnitees.
